AMAZING LOVE TUITION AID PROGRAM *ELIGIBILITY*

- The spirit of the Amazing Love Tuition Aid Program is to encourage member families seeking to continue their children's Christian education and not to solely act as a financial needs request.

Amazing Love Lutheran Church members and called workers seeking to further their children's Christian education, enrolled in schools within our fellowship, grades Pre K-12 plus at the university level, shall be eligible to apply to the Amazing Love Tuition Aid Program Fund for a grant. An application must be fully completed in order to be considered for eligibility (including providing the amount of the total out-of-pocket tuition net of any related tuition aid, grants, scholarships, tuition forgiveness, or assistance from the school or other institutions, include proper documentation of the child's current tuition balance from the applicable school, and proof of current year enrollment).

All applications received before the application deadline will be reviewed by the Amazing Love Leadership team. Sole discretion of the Annual Grants will rest with the Amazing Love Leadership team and their decision is final. Awards are dependent on the amount of gifts provided by the congregation during the current year, unused grants from prior years, or earnings on tuition fund balances and may not be sufficient to cover any or all tuition requests.

All annual grants will be provided directly to the school for the credit of the family being awarded the grant as soon as reasonably possible. In no circumstance will the total grant amount for a family be greater than the total cost of the family's total tuition bill at such school.
