## Boulevard Park Presbyterian Church of King County Articles of Incorporation

## **ARTICLE 1:** Name: <u>BOULEVARD PARK PRESBYTERIAN CHURCH OF KING COUNTY</u> Registered Name: <u>BOULEVARD PARK CHURCH</u>

**ARTICLE 2:** The purposes for which this corporation is formed are to receive, accept, acquire, own, hold title to, care for, manage, sell, dispose of or mortgage according to law, all of the real and personal property which has been or may hereafter be given to, contributed for or otherwise acquired by or for that certain religious organization known as the BOULEVARD PARK PRESBYTERIAN CHURCH OF KING COUNTY, which was organized on the 30th day of September, 1940, for the worship of the Almighty Triune God, and for religious teaching, Biblical training and Christian education work, and foreign and domestic missions, and all purposes not prohibited by law.

ARTICLE 4: Duration: Perpetual

**ARTICLE 5:** The members of said corporation shall consist of all those active in the church and who are approved for membership by the Board of Elders. Members may be removed from the roll by act of majority of the Board of Elders.

## ARTICLE 6:

The corporation shall have a Board of Elders of not less than four members who shall manage the temporal affairs of the corporation and who shall have final authority subject to these Articles of Incorporation and to the Constitution and Bylaws in all matters pertaining to the spiritual and material welfare of the corporation.

The corporation shall have a Board of Trustees of not less than three members who shall hold title to property and convey title and shall sign the name of the corporation to official papers. The Board of Trustees shall be subject to the authority of the Board of Elders.

## ARTICLE 7:

This corporation is organized as a church for Christian worship and evangelism, being organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code. Its assets are to be utilized for evangelical purposes in furthering the Gospel of Jesus Christ, for teaching the Word of God as revealed in the Old and New Testaments, and for the nurture of those professing faith in the Lord Jesus Christ. Notwithstanding any other provisions of these articles, the corporation shall not carry on activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (C) (3) of the Internal Revenue Code.

This corporation has the power to receive, accept, acquire, own, hold title to, care for, manage, sell, dispose of or mortgage according to law, all of the real and personal property which has been or may hereafter be given to, contributed for or otherwise acquired by or for the church corporation.

No member shall be entitled to benefit personally from the assets or income of the Corporation except for payment for services rendered as an employee of the Corporation. If at any time the Corporation is to be dissolved or assets are to be disposed of, the assets shall not be distributed to the members, but rather after paying or adequately providing for the debts and obligations of the Corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation, which is Christian and evangelical, which has established its tax exempt status under Section 501 (C) (3) of the Internal Revenue Code.

**ARTICLE 8:** Governing Persons: Corporate President, Corporate Treasurer, and Corporate Secretary.
