Release, Waiver and Assumption of Risk Agreement and "Waiver of Liability"

I, (please print) _____ hereby acknowledge and agree that in consideration of being permitted to participate in official programs or activities organized, operated or sanctioned by CrossWay Bible Church:

1. I do hereby release CrossWay Bible Church, it's members, officers, directors, employees, sponsors, independent contractors, facilities and agents of and from all liability, and do hereby waive as against CrossWay Bible Church, it's members, volunteers, officers, directors, employees, sponsors, independent contractors, facilities and agents all recourses, proceedings, claims, actions and causes of action of any kind whatsoever, in respect of all personal injuries or property losses which I may suffer arising out of or connected with my preparation for, or participation in, any youth programs or activities, notwithstanding that such injuries or losses may have been caused solely or partly by the negligence of CrossWay Bible Church, it's members, volunteers, officers, directors, employees, sponsors, independent contractors, facilities and agents,

2. And I hereby acknowledge and agree:

A. that I am at least 18 years of age. Waiver must be filled out and signed by parent or guardian if under the age of 18:

B. that youth programs and activities can be very dangerous, exposing participants to many risks and hazards, some of which are inherent in the very nature of the activity itself, others which result from human error and negligence on the part of the persons involved in preparing, organizing and staging sports programs and other activities:

C. that, as a result of the aforesaid risks and hazards, I as a participant may suffer serious personal injury, even death, as well as property loss:

D. that some of the aforesaid risks and hazards are foreseeable, but others are not;

E. that I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that, accordingly, my preparation for, and participation in the aforesaid activities shall be entirely at my own risk;

F. that I understand that neither CrossWay Bible Church nor any of it's members, volunteers, officers, directors, sponsors, independent contractors or agents assume any responsibility whatsoever for my safety during the course of my preparation for or participation in the aforesaid youth programs or activities;

G. If in the process of calling an ambulance service, the ambulance service shall have all authority as to whether a person is taken to the hospital or released to themselves or a caregiver not that of CrossWay Bible Church. Any and all financial charges that apply will be the responsibility of the injured party and their insurance. Any challenges to financial charges and the authority of the circumstance shall be discussed with the hospital, insurance, and the ambulance service. CrossWay Bible Church shall not be held responsible for the decision to transport the injured party by ambulance or for the financial charges of the hospital or ambulance service.

H. that I have carefully read this Release, Waiver And Assumption of Risk Agreement And Waiver of Liability, that I fully understand same, and that I am freely and voluntarily executing same;

I. that I understand clearly that by signing this release I will forever be prevented from suing or otherwise claiming against CrossWay Bible Church, it's members, volunteers, officers, directors, sponsors, independent contractors or agents for any loss or damage connected with any property loss or personal injury that I may sustain while participating in or preparing for any above mentioned youth programs or activities whether or not such loss or injury is caused solely or partly by the NEGLIGENCE of CrossWay Bible Church or any of it's members, volunteers, officers, directors, sponsors, independent contractors or agents;

J. that I have been given the opportunity and have been encouraged to seek independent legal advice prior to signing this agreement;

K. that I understand clearly that CrossWay Bible Church would not permit me to participate in any such youth programs and activities unless I signed the Release, Waiver And Assumption of Risk Agreement , that this Release, Waiver And Assumption of Risk Agreement applies to all aforesaid youth programs and activities whether occurring in the near or distant future, and that the terms of this agreement need not be brought to my attention each time I participate in a sports program or activity in order to be effective;

L. that the term youth programs or activities as used in this Release, Waiver And Assumption of Risk Agreement includes without limiting the generality of that term, the programs, events, and activities as well as all other activities, training sessions, planned off-site Renovate activities, programs and events that are in any way authorized, sanctioned, organized or operated by CrossWay Bible Church Renovate Youth Staff;

M. that this Release, Waiver And Assumption of Risk Agreement is binding on myself, my heirs, my executors, administrators, personal representatives and assigns;

N. I recognize that this release may be in addition to a release I must sign as a condition of participation or membership and that I am bound by the terms of both waivers;

O. Photo Release. I hereby grant CrossWay Bible Church and it's photographers the right to use my likeness in any publication, including website entries and prints, without payment or any other consideration. I understand and agree that any photographs taken by CrossWay Bible Church photographers are the copyrighted work of those photographers and may be altered, edited, copied, printed or distributed at the photographer's discretion or at the discretion of CrossWay Bible Church and it's representatives.
