FROM THE TRANSPORTA-TION COMMITTEE:

During the September 22nd business meeting, a question arose regarding dual wheel axle 15passenger vans being safer than single wheel axle 15-passenger vans. Because dual wheel axles only come on high roof vans, and because according to the National Transportation Safety Board, all high roof vans, including dual wheel models, have a lower safety rating than single wheel vans, we eliminated high roof vans early in our discussion.

The Transportation Committee would like to amend the motion tabled during the September business meeting to now purchase two 15-passenger mid roof vans at a cost of \$64,463.20 each for a total cost of \$128,926.40. This is an increase in cost of \$2,181.90 over the previous motion and includes the addition of a towing package and running boards not included in the original motion.

Following the purchase of the two vans, the decision will be made on whether to keep or sell our 25passenger bus.

The Transportation Committee also requests that if anyone has questions concerning the purchase of the two vans, please feel free to contact any member of the committee in the days prior to the October 27th business meeting so that we may find an appropriate answer to your question.
