6 7	Article I. Name The name of this nonprofit corporation is the First Baptist Church, Icard, Inc. (the "Church").	
8 9 10 11	Article II. Purpose The Church is organized exclusively for religious, charitable and educational purposes as permitted under Section 501(c)(3) of the Internal Revenue Code (the "Code"), including, but not limited to, the following:	
12 13 14 15 16 17 18	 WORSHIP – To participate in public worship services through prayer, singing, giving, and the proclamation of the Word. DISCIPLESHIP – To promote personal, spiritual growth through Bible teaching. MINISTRY – To serve those in our church, community, and world according to the example of Jesus Christ. MISSIONS – To share the good news of Jesus Christ with our community and the world. 	•
19 20 21 22 23 24 25	Through this purpose, we commit to invest in one another through encouragement, support, and prayer as we share our lives together. Article III. Statement of Faith We affirm the Holy Bible as the inspired Word of God and as the only basis for our beliefs and practices. This Church ascribes to "The Baptist Faith and Message 2000 (as amended in 2023)" as the general statement of our faith in addition to other statements contained in our bylaws.	
26 27 28 29 30 31	Article IV. Affiliation and Governance As a Baptist, we affirm congregational polity. We recognize the benefits of cooperation with other churches in local and international missions, therefore we voluntarily affiliate with the Southern Baptist Convention, the Baptist State Convention of North Carolina, Catawba Valley Baptist Association, and the Catawba River Baptist Association.	
32 33 34	Article V. Congregational Membership The Church shall be composed of members who meet the following requirements.	
35 36 37 38 39 40	 A. A statement of personal commitment of faith in Jesus Christ for salvation. B. Baptism by immersion as a testimony of salvation. C. Participation in the Prospective Members Class, signing and committing to abide by the FBI Membership Covenant, and receiving a majority vote in a business meeting. All members are expected to remain active in the worship of the church and abide by the FBI Membership Covenant. After a year of inactivity, a member will be automatically removed from

5	Article VI. Church Meetings	
6 7 8 9 10	The Church shall hold meetings of the members for worship, teaching, training, outreach, fellowship, and business. Written minutes of all business meetings will be kept by the Church Clerk and available for review. Twenty (20) percent of members shall constitute a quorum of the membership for the transaction of business. All recommendations requiring a two-thirds approval will be done by secret ballot.	
11 12	A general business meeting of the members shall be held quarterly and at such times as determined by the Elders after the Sunday Morning Worship Service.	
13	Article VII. Officers	
14 15 16 17	The Trustees will serve as corporate officers. The chair will serve as President and the vice-chair will serve as Vice President. The moderator of business meetings will be chosen annually by the Elders in their first meeting each year and will serve at the discretion of the Elder Board as described in the bylaws.

28 29 30	In the event of its dissolution, the Church, after paying or making provision for the payment of all the liabilities of the Church, shall distribute all of the net assets of the Church to one or more	
31	organizations which themselves are exempt as organizations described in Sections 501 (c) (3) and 170 (c) (2) of the Code organized for like purposes as the Church.

1	Article XII. Amendments
2 3 4 5 6	The Articles may be changed or amended during a properly called meeting of the Church. Amendments to be considered must be presented to the Elders and Deacons. The Elders and Deacons will present, in writing, any changes to be made to the entire Congregation at least two weeks prior to the meeting. In order to approve the amendment, it must be accepted by a two-thirds vote of the members present and voting.

8	Article XII. Effective Date; Validate
9 10 11	The Articles shall be effective upon filing in the office of the North Carolina Secretary of State. The adoption of the Articles shall not invalidate any action validly taken by or on behalf of the Church to the date the Articles of Incorporation becomes effective.
