



**GRACE POINT CHURCH  
ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY, AND  
HOLD HARMLESS/ INDEMNIFICATION AGREEMENT**

For valuable consideration received, including but not limited to my being allowed to participate in activities and functions sponsored by Grace Point Presbyterian Church ("Grace Point Church"), the receipt and sufficiency of which is acknowledged, I agree to the following terms and conditions.

I understand that activities sponsored by Grace Point Church, including but not limited to meetings, events, ministries, small groups, and trips (collectively and inclusively, the "Activities") are wide-ranging and that some may include inherent risks. I understand that participation in the Activities is optional, as no person is required to participate in any activity, and a person should only participate in those Activities with which he/she is comfortable. I am fully aware of the risks, dangers, and other hazards connected with the Activities, and I elect to participate knowing that the Activities may be hazardous to me and my property.

**I KNOWINGLY, FREELY, AND VOLUNTARILY ASSUME THE RISKS, BOTH KNOWN AND UNKNOWN, OF ANY LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, THAT MAY BE SUSTAINED BY ME, AND/OR LOSS OR DAMAGE TO PROPERTY OWNED BY ME, AS A RESULT OF PARTICIPATION IN THE ACTIVITIES, EVEN IF ARISING FROM THE NEGLIGENCE OF THOSE RELEASED FROM LIABILITY BELOW. I FURTHER ASSUME FULL RESPONSIBILITY FOR MY ACTS OR OMISSIONS AND ANY LOSSES, INJURIES, OR DAMAGES MY ACTS OR OMISSIONS MAY CAUSE.**

**I, FOR MYSELF AND MY HEIRS, SUCCESSORS AND ASSIGNS, HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE** Grace Point Church and its affiliates, directors, officers, employees, servants, agents, volunteers, successors, and assigns (collectively, the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death or disability, that may be sustained by me, or to any property belonging to me, while participating in the Activities, and while in route to or from the Activities, even if arising from the negligence of the Released Parties, except that which is the result of gross negligence or reckless, willful, or wanton misconduct.

**I AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS** the Released Parties from any and all claims, losses, injuries, and damages that may arise from my participation in the Activities, including but not limited to claims by third parties and any claims submitted by me or on my behalf, even if arising from the negligence of the Released Parties, except that which is the result of gross negligence or reckless, willful, or wanton misconduct.

It is my expressed intent that this agreement shall bind me, my family, and our respective heirs, assigns, and personal representatives, and that this agreement be enforced to the maximum extent permitted by law.

**I HAVE READ THIS ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY AND HOLD HARMLESS/ INDEMNIFICATION AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, STATEMENT, OR REPRESENTATION, WHETHER WRITTEN OR ORAL.**
