Slots will be filled first come – first served.

## **SCHEDULE**

Lessons will begin the week of September 23. Music lessons will be given during school hours on a rotating schedule so children will not miss the same class time each week. Every effort will be made to avoid having students miss "specials" classes that occur only once a week, or any classes in which they might find a struggle to keep up. Students will be responsible to make up the classroom work that is missed during lesson time, and to practice their instrument during the week. Each lesson is one-half hour long, once per week.

## **GROUP SIZE**

Private and semi-private lessons will be offered, with availability based on interest/experience level, and scheduled time slots. The teacher will communicate with parents if she feels any student's learning style and ability warrant a different group size once lessons start. She will also communicate with you if any student is beyond the level of lessons being offered, at which point a specialized teacher would be recommended to you for the following term.
